1. Minutes of the last GPF meeting held 20/3/2022

The minutes were discussed and approved. No matters arising not otherwise on the agenda.

2. <u>Trustee/Committee Member matters</u>

It was noted we had apologies for absence from Lydia Leather. Michael Butcher has stood down as BCRA rep from this meeting and will be replaced by Robert Watson.

Decision to reinvest a United Trust Bond £27.5k to be reinvested (1 year fix) at 2.96% maturity October 2023.

3. <u>Discussion regarding 2022 funding of applications and finance report</u>

PI introduced his finance report.

Expeditions ring fenced in 2020 and 2021 have following status; Mulu to go in October 2022, Nagaland in December 2022, Papua to probably go in 2024. Previous approved ring fenced funding still applies.

7 expeditions that were supported in Round 1 occurred in summer 2022 and 2 have reported back already.

Further bond of £50k matures in December 2022 and we should be able to invest at around 3%. With GPF holding circa £200k then at 3% interest should get up to £6k p.a. once they have all renewed at higher rates. **Action Trustees**

Updated accounts circulated, including a substantial donation of £4,300 from P Villa. Investigate the source **Action PI**.

Examiner for Trustee report and accounts has been Alastair Gott and Paul will ask him if he would do so again. Report needs to be submitted to Charity Commission by end October 2022. **Action PI**.

4. Consideration of autumn applications 2022

It was noted that despite publication of the deadline, no applications had been received.

5. Review of outstanding actions from previous meetings

6. Members update.
